Environmental Regulations Tightened for Federally-Guaranteed Lenders and Applicants

WASHINGTON: Effective August 1, 2008, the United States Small Business Administration has put stringent new environmental standards into effect, adding additional complexity for lenders and applicants of SBA-backed loans.

The new operating procedures, designated SBA SOP 50-10(5), identify more than 70 categories of "environmentally sensitive industries" that must adhere to one of four regulatory paths based on such criteria as loan size and current or prior use of the property. In addition, the regulations place a new burden on environmental professionals, who must provide reliance letters for environmental assessments they perform on behalf of lenders.

"These new regulations dramatically increase the due diligence required of lenders for SBA-backed loans," says Jeffrey Dooney, Vice President of TERMS Environmental Services. "Many SBA lenders have now found themselves in a position where they must evaluate factors unfamiliar to them and make determinations which they may not be completely qualified to make." The downside for lenders is failure to comply with the new requirements puts them at risk of losing the financial backing that the SBA provides on these loans.

To assist lenders and applicants navigate these new requirements, TERMS has developed a set of free web-based tools specifically designed to address SBA guidelines. Its SBA Compliance Service includes a databank of all relevant forms and regulations, an Environmental Questionnaire required of all applicants, listings of affected industries and businesses, and a 24/7 HelpDesk. The centerpiece of the new service is an online calculator that determines what must be done for a specific set of lending conditions.
